# **Instruction to Authors**

Journal of Health Science is published by Health Technical Office, Ministry of Public Health, Thailand. The Journal has been published regularly since 1992. The publication is managed by the Editorial Team appointed by the Ministry of Health. The team is comprised of outstanding technical experts within the Ministry as well as those from various leading medical and health institutions. In addition, several multidisciplinary experts are invited to support the Journal in the capacity of reviewers who carefully reviewed the quality of submitted manuscripts before being accepted for publication. Six issues of the Journal are produced each year: (1) January–February, (2) March–April, (3) May–June, (4) July–August, (5) Spetember–October, and (6) November–December.

The Journal of Health Science welcomes all kinds of health-related articles. These included:

- 1. Original article
- 2. Review article
- 3. Special article
- 4. Case report
- 5. Miscellany
- 6. letters to the editor

etc.

Each manuscript must not be published elsewhere, and the manuscript should not exceed 10 pages.

#### **Preparation of Menuscript**

A manuscript should be prepared as follow:

- 1. The structure of original article should be in the following order:
  - Title,
  - Author name(s), with abbreviation of academic qualification (such as B.Sc., M.D., or Ph.D.),
  - Author address(es),
  - Key words, 1-5 key words in alphabetic order,
  - Introduction,
  - Material and Methods,
  - Results.
  - Discussion,
  - Acknowledgement, and
  - References.
- 2. The Health Science Journal uses a citation method that follows the Uniform Requirements for Manuscripts Submitted to Biomedical Publication (Vancouver Style). Abbreviations should be based on the U.S. National Library of Index Medicus (see examples below).
- 3. To submit a manuscript, three sets of the printed manuscript should be sent to the following address:

In addition to the hard copies, a CD containing the electronic file of the manuscript with separate files for figures should also be attached.

#### Submission of a manuscript

The submitted documents should include a cover page containing information on the corresponding author who will be responsible for communicating with the Journal regarding the process required for the improvement of the manuscript. Such information includes name, office phone number, mobile phone number and an e-mail address. It is encouraged to submit the manuscript by email in addition to the hard copies and the CD. All submission will be acknowledged by the Editor. Those unaccepted will also be notified. The Editor reserves right to edit all manuscripts for proper publication according to the format of the Journal.
